Purchase of Service X

The following Transportation contracts have been reviewed by Lynn Nguyen, Director, Finance and Administration and Lisa Kleinbub, Executive Director, both of whom recommend approval by the RCEB Board of Directors.

SERVICE CODE - 875

Each vendor has a rate based on the transportation cost statements submitted during the initial vendorization. If the vendorization occurred prior to the implementation of the Statewide Median Rates on July 1, 2008, then we were able to negotiate a rate based on the transportation cost statements that may have resulted in much higher rates. Vendors would have submitted details on costs such as salaries and wages, fringe benefits, operating expenses, insurance, etc. to provide transportation services. For those vendors vendored after July 1, 2008 for service code 875- transportation companies, regional centers could negotiate the rate up to the allowed Statewide Median Rate. Due to the Statewide Median Rates, vendors would only receive up to the max allowed although their transportation cost statements would have resulted in a higher rate. Current rates reflect the rate increases provided through legislation and implemented based on Chapter 76, Statutes of 202 (AB136).
