## Agenda Item: Meeting Plans for 2016

We will continue to alternately meet at both RCEB's San Leandro and Concord offices starting with the January meeting in San Leandro. Vi inquired to the committee on what they would like the meetings to be like for the beginning of the year, and what kind of trainings would be presented. It was recommended that we move the Independent Facilitator Presentation to the January meeting since we had only half the committee in attendance (at the beginning of the meeting).

# **Agenda Item: DDS Updates on Self-Determination** – Pam Thomas and Will Sanford Status

As reiterated before, the Home and Community-Based Services Waiver application was submitted by the Department to the Centers for Medicare and Medicaid Services [CMS] back in September with the expectation that we would hear a response within 90 days. CMS responded *informally* back to the State with 180 questions; many of them related to the CMS rules. There were definite denials in regards to college costs such as tuitions and books, and massage therapy treatments. We are expecting a *formal* list of questions from CMS by the end of December, then the Department will work through the Department of Healthcare Services to submit the answers, and once that is submitted, there is another 90 day deadline for CMS to respond.

# **Outreach and Training**

The DDS Workgroup headed by Jim Knight will continue to conduct conference calls every two weeks, and they are also pushing DDS to move forward with the outreach/training for regional center staff by March 31<sup>st</sup>. There is also a consensus that the materials that our case managers are trained on, should also be available to our SD advisory group. Pam brought up that in the SD law, we need to contract with the family resource networks to assist with outreach and that we could invite them; both care and FRN's to one of our meetings early in the 2016 year to talk to them about outreach, so that we can begin to have the discussion on how we are going to proceed. We are very fortunate to have strong DDC's both in the Contra Costa and Alameda counties who do a lot of outreach in the community. Other organized sources for outreach are parent associations, SF Autism Society, Down Syndrome Connection of the Bay Area, etc.

DDS has the training video's up on their website and is currently working on voice-overs in 21 languages.

#### **Work Group Discussions**

- The State Council still needs to organize the SD Chairs meeting, which would benefit all the local SD advisory committees since there are many questions, trainings and information that can be shared at these statewide meetings.
- The workgroup has been discussing the details of FMS payment, rate structure and funding as well as a variety of other topics related to FMS. Pam added that when

- choosing an FMS provider, the family really needs to pick a provider with a strong financial background and experience in this program.
- The topic of the workgroup being more transparent by providing minutes was brought up at the last conference call. The response was that if they formalize the meeting and provide all that information, then they are subject to Bagley-Keene Open Meeting Act which legislates methods by which public meetings are conducted on the state level. They want to emphasize that this is an advisory work group and want to meet freely, but they will take calls in to listen to the meeting and the public is welcome to attend if they meet in person. Their next conference call meeting is on February 10, 2016.
