Call to Order:

Meetings called to order at 9:40 am. Introductions. May 11th minutes approved.

RCEB/State – Lisa Kleinbub

- The self-determination waiver was approved by federal government. How it will be implemented will be decided within the next 6-8 months.
- HCBS grants were awarded, and the state wants to make sure that individuals being served have the opportunity to provide input on the formation of HCBS services.
- The RCEB currently has cash for June payments on POSs and is doing a cash flow analysis on where payments for July will come from. Because the RCEB has a line of credit available to them July payments will still happen no matter what. It is the hope that next year DDS will have more funds available to them to solve this problem and prevent it from happening next year.
- The State is currently looking at changes in how health and safety request are handled, especially for minimum wage cities. More information about this will be available this July.
- Regional Centers are currently waiting for guidelines on how to ask for community placement plans and community resource funds, specifically in relation to crisis and housing services.
- Currently we are 34 people away from completing all placements from Sonoma Developmental Center. All homes will be finished late July and move ins will be completed in August to October at the latest.
