As of July 1, 2022, the cost of FMS is not paid by the SDP Participant. Name, model, and cost of FMS still has to be identified in the Spending Plan at the time of submission to RCEB.. Availability for enrollment dates differ based on FMS model and FMS agency. Inquire with chosen FMS to learn more.

INSTRUCTIONS:

1. Certify Individual Budget



Some FMS consider the budget when determining availability; begin contacting after you have a certified budget to determine if an FMS can help manage your funds for the year. Ask when the FMS can begin managing your SDP case.

2. Complete Spending Plan



Include the name, model, and monthly cost of FMS. Ask when the FMS can begin managing your SDP case. Try to be specific in the description of services needed. If you do not know a provider, service, or product yet, that is ok. However, keep in mind, if there is a question about a service or product, the FMS will not fund until they have consulted with RCEB first.

3. Participate in IPP meeting



Your Case Manager will sign off on the Spending Plan after this meeting to verify everything in the Spending Plan supports your IPP goals. To streamline this meeting, you may send a draft Spending Plan to your Case Manager for initial review in Step 2. Confirm when the FMS can begin managing your SDP case

4. Purchase Orders to FMS



Your Case Manager will cancel Traditional Model POS before writing the Purchase Order to your FMS. When RCEB Accounting has processed the purchase orders, your signed Spending Plan is sent to the FMS to begin to manage. Provide the information of your FMS contact for best coordination. **SDP Participant and/or chosen supports ensure Providers in SDP are registered with chosen FMS by the enrollment date to avoid disruption in services.**
