Summary:

Friends of Children with Special Needs (FCSN) is vendored separately for transportation as an additional component to provide transportation services to individuals attending one of the FCSN programs that include the Adult Development Center, Community Integrated Day program, and Adaptive Skills Training.

Learning Integration Friendship Empowerment (LIFE): Community Integrated Program assists each person to develop/discover their unique potential in settings that utilizes individual strengths in the community through a variety of activities that they determine most valuable and important to them. They have access to community resources such as paratransit and fixed route. The program supports individuals to navigate the community safely during program hours and by providing transportation to/from home and the meeting site.

FCSN East Bay Adult Day Program: Adult Development Program provides a community based day program for adults that emphasize their roles within their families and community and respects the traditional roles and culture of the individual and family. They have access to community resources such as paratransit and fixed route. The program supports individuals by providing transportation to/from home and day program site when there is a safety concern; the person is unable to access community resources, or to provide smaller route options to reduce length of time on route.

FCSN Adaptive Skills Training Program: Adaptive Skills Training is an intensive 1:1 service that includes a variety of modalities such as social skill group, vocation and educational activities, community outings, expressive activities, recreation, social, leisure skill building and structured schedule of preferred activities. The program supports individuals by providing transportation to/from home and meeting site based on preferred activity.

Contract Overview:

The attached Service Provider Agreement represents Purchase of Service (POS) funding for FCSN transportation services for adult individuals who are clients of RCEB. For rate details please refer to the RCEB Contracts for Board Review/Approval form.
